V. EMPLOYEE SERVICE AWARDS

Chair Wilkes presented Langston Jackson with a 5 Year Service Award and Kelly said the following: Langston is often referred to as Langston Hughes (the noted poet and author) by so many of our customers/Educators, currently works as an In-Take Technician with the Application side of the Ethics Department. (Side Note: His name was inspired by Langston Hughes, as Mr. Hughes was the favorite poet of his mother and grandmother, both educators.)

Langston's career as a public servant began while attending college. From 1999 to 2003, he worked for the United States Department of Education. In 2004, he began his career with the state of Georgia as a Program Assistant with the Department of Administrative Services (DOAS). After a year with DOAS, he was hired with the PSC as an Evaluation and Information Specialist.

Langston has been with the Ethics Department for a year. Coming from the Certification Department, he has bridged the gap between the Investigative Department and the Certification Department.

He speaks certification as well as several other languages. Given the fact that he is a Millennium Baby in a Department full of Baby Boomers, he speaks computers (which are a God send to some of us). He speaks popular culture, meaning he has the ability to help Investigators with interviewing students and 20 something educators. - Taught math, technology, journalism and economics at his alma mater, Bleckley County High School, where he was named Teacher of the Year in 2006 and served as teacher representative on the School Council.
- Last year, his Economics EOCT scores were the highest of any school in the Heart of Georgia RESA district.
- Steve was recently named Superintendent-elect for Wilcox County and will begin serving July 1, 2009

Andre Mountain – He completed Wesleyan/Bibb College GaTAPP Program

- He received the *Exemplary Teachers Scholarship for Graduate Studies, 9/03* awarded to teachers who provide innovative learning experiences for elementary students.
- Mountain is a 5th grade language arts teacher at Monte Sano Elementary, and the only male teacher at the school.
- In 2008 he was the Teacher of the Year for Monte Sano and went on to become a Teacher of the Year finalist for Richmond County.

9. APPLICATIONS FOR CERTIFICATION REPORT

The Educator Ethics Review Committee recommended to approve a no probable cause determination on 29 cases reflected on the *Applications for Certification Report*.

10. REVIEW HEARING EXTENSIONS

The Commission reviewed the *Review Hearing Extensions Report* concerning 2 hearing cases. An Administrative Law Judge rendered Initial Decisions on each case referenced in the report. The report indicates Orders were issued.

11. STUDENT LOAN SUSPENSION / REINSTATEMENTS

The Committee reviewed the Student Finance Commission Report concerning educators in which notification has been received to suspend certificates for default on repayment of student loans. The report indicated that there were 8 certificates suspended from February 12, 2009 through March 12, 2009.

The Committee was also advised that there were 10 certificates that had been reinstated because restitution is now being made on those student loans.

The Committee was also advised that there were 5 issues where notification had been received to suspend but releases were received prior to the actual suspension being implemented. Restitution is now being made on those student loans.

12. FINAL DECISIONS BY OPERATION OF LAW

The Committee reviewed the report, which advised of 19 cases now closed without an appeal for a hearing before an Administrative Law Judge. The report also advised the Committee that there were 1 cases closed without an appeal for a review hearing before the Commission.

The Commission hereby ORDERED that the application filed by LOIS CARLISLE for a Georgia educator certificate be DENIED effective March 12, 2009. All requirements prescribed by Rule 505-6-.02(1)(b) shall apply. Ms. Carlisle will become eligible to Petition for the Right to Reapply for a Georgia educator certificate two years from the effective date of this Final Order. If the Respondent decides to appeal this decision, he/she must file a petition within 30 days after service of this Final Decision pursuant to O.C.G.A. § 50-13-19.

X. EXECUTIVE SECRETARY REPORT

The Executive Secretary presented the following:

A. Legislative Review – Kelly gave the commissioners a “Bill Status Chart” and spoke briefly on the House Bills and their status.

B. Master Teacher-Ethics Cases - We had agreed that PSC staff would make determinations on whether or not an educator with a warning or reprimand would be allowed to apply for Master Teacher. We also agreed that educators with revocations would not be allowed to apply, and that educators with suspensions would be brought to the Commission for a decision. The 5 educators listed below would like to apply for Master Teacher:

Educator A – All three cases involved student loans and all three were resolved within a matter of a few days after the educator was notified. If the procedures we use today were applied to this educator’s cases, no sanction would be given.

Recommendation: Allow educator to apply for Master Teacher.

Educator B – The case was a student loan. This was resolved the same day the educator was notified. If the procedures we use today were applied to this educator’s case no sanction would be given.

Recommendation: Allow educator to apply for Master Teacher.

Educator C – This educator has a pending ethics case.

Recommendation: Do not allow this educator to apply for Master Teacher at this time

Educator D – This case involved Abandonment of Contract. The educator left a private school for employment in a public school. The educator felt that she had been granted a verbal release by the principal, but the head of school and governing board denied the release. The educator has an exemplary record in the public school system since this case was seen by the Commission in 2001.

Recommendation: Allow educator to apply for Master Teacher.

Educator E – This was a testing case. The educator developed an ITBS practice sheet that mirrored the actual test. The practice test questions were developed from notes from a previous test (these notes were based on student recall). There was no test administration training provided (This case came from school year 2000-2001). The study sheet did not appear to have helped students (based on a comparison of scores) but it did violate the “mirror items” testing protocol. The school district informs us that this is an excellent educator.

Recommendation: Allow educator to apply for Master Teacher.
